

OPERATING RULES - STANISLAV JUNGWIRTH STADIUM

ENGLISH

Tělocvičná jednota Sokol Roztoky u Prahy

General Scope & Applicability

These operating rules were approved by the Board of TJ Sokol Roztoky and are binding for all users and visitors of the stadium, including:

- Active athletes of TJ Sokol, SK Roztoky, and players/competitors of visiting teams,
- Accompanying persons (coaches, teachers, parents),
- Spectators of sports matches and visitors of cultural events,
- Regular and one-time tenants (Roztoky Primary School, SK Roztoky, etc.),
- General public using the stadium during designated public hours.

I. General Rules Applicable to the Entire Complex

- The TJ Sokol Roztoky Stadium primary purpose is sports activities of TJ Sokol and organizations/groups with a valid lease agreement (SK Roztoky, Roztoky Primary School, etc.).
- Residents of Roztoky and Úholičky may use the athletic track for running workouts free of charge on Tuesdays, Thursdays, Saturdays, and Sundays between 18:00 and 20:00. Exceptions apply during track meets or official football matches. For safety reasons, the general public is not permitted to use technical discipline sectors (pole vault, high jump, long jump, throw/put sectors).
- All activities on the stadium are subject to the schedule approved by the TJ Sokol Board (see www.sokroz.cz).
- Coaches or teachers are fully responsible for safety and compliance with the operating rules during training sessions or physical education lessons.
- The following are strictly prohibited within the stadium complex: entry of motor vehicles (except with written TJ Board permission); walking or exercising dogs; consumption of alcoholic beverages and smoking (outside strictly designated areas).
- Every user is obliged to handle sports surfaces with care, especially under adverse weather conditions (waterlogged turf, soft clay courts, etc.).
- In case of damage or malfunction, every member of TJ/SK is obliged to report it immediately to TJ Sokol management (contacts at www.sokroz.cz) for rapid repair.
- All stadium entrances are locked at 22:00.
- Facility managers, board members, and coaches of TJ Sokol and SK Roztoky have the right to expel any person violating these operating rules.

II. Video Surveillance System & Personal Data Protection (GDPR)

- The outdoor complex, athletic track, and surrounding areas are monitored by a CCTV system with recording capabilities for property protection, visitor safety, crime prevention, and vandalism deterrence.

- **Legal Basis:** Legitimate interest of the controller under Art. 6(1)(f) GDPR.
- **Retention Period:** Video recordings are kept in a continuous loop for up to 7 days, after which they are automatically overwritten.
- **Incident Handling:** In case of an incident (property damage, unlawful act, injury), relevant video excerpts are retained and transferred to law enforcement or insurance companies for damage recovery.
- **Data Subject Rights:** Visitors have the right to request access to their personal data, restriction of processing, and to lodge a complaint with the Personal Data Protection Office (www.uoou.cz).
